The accompanying Magellan Pipeline Company, L.P. ("MPL") tariffs, issued on December 1, 2023, to be effective on January 1, 2024, are sent to you for filing in compliance with the requirements of the Interstate Commerce Act and the rules and regulations of the Federal Energy Regulatory Commission. Said tariffs are issued by Jake Nolte, Supervisor, Tariffs, for MPL, and are concurred in by all carriers named therein as participants under the concurrences or authorizations now on file with Carrier.

**F.E.R.C. No. 166.31.0 canceling F.E.R.C. No. 166.30.0, IS23-400-000**  
**F.E.R.C. No. 171.37.0 canceling F.E.R.C. No. 171.36.0, IS23-400-000**

**F.E.R.C. No. 166.31.0** contains joint rates which have been increased. These increases synchronize with Explorer Pipeline's local tariff rate increases reflected in **F.E.R.C. No. 100.117.0**, filed December 1, 2023 to be effective January 1, 2024 (Docket No. IS24-97-000) under Explorer's market-based ratemaking authority, which was granted by the Commission in Docket No. OR99-1-000, issued June 30, 1999 (87 FERC ¶ 61,374).<sup>1</sup> No other changes have been made, except updates to references of current tariff numbers where applicable.

**F.E.R.C. No. 171.37.0** contains incentive rates which have been increased. These increases synchronize with Explorer Pipeline's local tariff rate increases reflected in **F.E.R.C. No. 100.117.0**, filed December 1, 2023 to be effective January 1, 2024 (Docket No. IS24-97-000). All rates in **F.E.R.C. No. 171.37.0** are below the corresponding base rates.

No. 166.31.0** were established under authority of 18 CFR 342.4(b) pursuant to the Commission's finding of lack of market power in Opinion No. 391 (68 FERC 61,136) and Opinion No. 391-A (71 FERC ¶ 61,291) and 18 CFR 342.4(b) – *market based* pursuant to the Commission's Order on Application for Market Power Determination, Longhorn Partners Pipeline, L.P., Docket No. OR98-12-000, issued June 30, 1998 and 18 CFR 342.4 (b) – *market based* pursuant to the Commission's Order on Application for Market Power Determination, Chevron Pipe Line Company, Docket No. OR00-6-000, issued April 25, 2001.
