In accordance with the requirements of the Interstate Commerce Act and the Rules and Regulations of the Federal Energy Regulatory Commission (“Commission”), Magellan Pipeline Company, L.P. (“MPL”), a subsidiary of ONEOK, Inc., submits the following tariffs effective March 1, 2025:

F.E.R.C. No. 157.35.0 cancels F.E.R.C. No. 157.34.0 (Docket IS24-810-000)
F.E.R.C. No. 159.30.0 cancels F.E.R.C. No. 159.29.0 (Docket IS24-810-000)

Explanation of Tariff Filing

MPL is filing F.E.R.C. Nos. 157.35.0 and 159.30.0 with updates to Item No. 40 in both tariffs referencing product grade documents and adding two new product grades. Pursuant to provisions specified by the Clean Air Act, the governors of Illinois, Iowa, Minnesota, Missouri, Nebraska, Ohio, South Dakota, and Wisconsin submitted petitions requesting that the Environmental Protection Agency (“EPA”) remove the 1-pound per square inch (“psi”) Reid vapor pressure waiver for summer gasoline-ethanol blended fuels containing 10 percent ethanol. The EPA is acting on those petitions by removing the 1-psi waiver in the aforementioned states effective April 28, 2025 under Docket ID No. EPA-HQ-OAR-2022-0513. These and other tariff changes are further explained below.

The following revisions are made to F.E.R.C. No. 157.35.0:

- The Title Page revises the applicable C.F.R. regulation for this filing.
- Administrative changes are made to update page numbers in the Table of Contents.
