Explanation of Tariff Filing

This filing is made to index MPL’s ceiling levels and rates in compliance with 18 C.F.R. § 342.3, Indexing. As required by 18 C.F.R. § 342.3(b), attached is a schedule indicating: (1) the ceiling levels for the period July 1, 2025 to June 30, 2026; (2) the current tariff rates; (3) the new ceiling levels for the period July 1, 2026 to June 30, 2027; and (4) the proposed new tariff rates effective July 1, 2026. The proposed new rates are less than or equal to the corresponding new ceiling levels.

Pursuant to 18 C.F.R. § 342.3, the tariffs filed herein reflect an increase in rates (unless otherwise noted) in F.E.R.C. Tariff No. 157.39.0, Item Nos. 85, 150, 155 and 160; F.E.R.C.

The rates in the tariffs, which are below the ceiling level, remain unchanged. F.E.R.C. Tariff No. 176.2.0 and F.E.R.C. Tariff No. 205.0.0 are therefore not included in this filing.

The title page of F.E.R.C. Tariff No. 157.39.0, F.E.R.C. Tariff No. 158.40.0, F.E.R.C. Tariff No. 159.35.0, F.E.R.C. Tariff No. 160.57.0, F.E.R.C. Tariff No. 173.21.0, F.E.R.C. Tariff No. 184.37.0, F.E.R.C. Tariff No. 185.29.0, F.E.R.C. Tariff No. 188.12.0, and F.E.R.C. Tariff No. 193.13.0 have been updated to reflect the C.F.R. reference applicable to this filing. Also, throughout the tariffs, administrative edits have been made.

Waiver

Pursuant to 18 C.F.R. § 341.2(c)(1), MPL has not identified any waivers of the Commission's regulations needed to permit its filing to become effective as proposed. However, MPL respectfully requests that, should the Commission determine that any such waivers are required, the Commission grant such waivers as are necessary in order that the revised tariff records may be made effective as proposed.
